Bus Behavior Expectations **(For Students on Field Trips and Assigned Routes)**

The transportation services provided through the Los Angeles Unified School District are a privilege intended to provide students and families with a safe and cost effective means of traveling to and from school. With this understanding, it is important that students adhere to a strict set of safety guidelines in order to ensure each child's arrival at their destination. When in transit to and from school or related activities, students are expected to adhere to all of the behavior guidelines set forth by both Paul Revere Charter Middle School and the Los Angeles Unified School District. Failure to do abide by these rules may result in disciplinary action, including but not limited to loss of transportation privileges.

Rules and Expectations

All passengers must:

1. Remain seated with seat belts fastened, facing forward at all times
2. Refrain from loud or disruptive behavior that may distract the bus driver
3. Keep all body parts and personal objects inside the bus and away from the aisle
4. Be respectful to all passengers and staff members
5. Refrain from eating or drinking on the bus or in the loading zone
6. Keep all electronic devices out of sight. Refrain from using any electronic device, except in an emergency situation or prior permission from driver
7. Have bus pass at all times and get off bus only at assigned stop
8. Wait at assigned stop 5 minutes prior to pick up time
9. Have driver assist in crossing the street when bus is present or in view

Disciplinary Consequences -

Assigned Bus Route

1. Verbal Warning
 2. Citation #1 – Warning
 3. Citation #2 – 1 day suspension, return pending parent conference
 4. Citation #3 – 3 day suspension, return pending parent conference
- *Violation of any bus rules after citation #3 may result in loss of transportation privileges for the duration of the school year.

Late Buses

1. Citation # 1 – loss of late bus privilege for the duration of the semester.

Automatic Suspension (3 days minimum)

The following actions will result in a suspension from transportation and a parent conference:

1. Fighting, horseplaying, putting hands on another student
2. Getting off bus at an unassigned stop without permission from administration
3. Endangering the safety of passengers, the driver, and/or the public (throwing object out windows, threatening a staff member or another student, moving seats while bus is in motion, etc).
